None of the cases are state- or time-specific so they can be used in any jurisdiction at any time. With these CDs, the student will be able to analyze cases while producing legal documents and preparing legal research, just as paralegals do in actual law offices. By completing these exercises, a paralegal can develop the practical skills necessary to function as a valuable and effective member of a legal team. State v. Manion: Involves a criminal case involving a man who has been fatally shot. The ensuing investigation results in an indictment of the deceased's widow. The student will be asked to assist either the prosecutor or the defense team.
